MINUTES OF ICCOBA EXECUTIVE MEETING HELD ON SUNDAY, DECEMBER 10, 2023.

MEMBERS PRESENT:

Sunday Uwumarogie Presley Omoruyi Kenny Giwa Osagie Ise Osayimwen Osagie Eweka John Owie Dala Iguodala Babatope Atafo Ogulogu Obaide

The president Mr. Sunday Uwumarogie called the meeting to order at 7.10 pm (CDT). The meeting began with opening prayers by Kenny Giwa Osagie. Tope Atafo, the Canada Chapter President then introduced the Canada Secretary General, Ogulogu Obaide to give the exco an update on preparations for the 2024 Toronto Convention. Mr. Atafo did further add that if Mr. Ogulogu had to leave for work before completing his report, he Atafo would finish it up. The President, Mr. Uwumarogie then interjected to enable the house to complete some basic exco meeting processes.

Mr. Uwumarogie thanked the assistant General Secretary, Ise Osayimwen, for putting the minutes together. No corrections to the previous minutes were proposed. Subsequently, a motion to adopt the minutes was moved by Mr. Osayimwen and seconded by Mr. Uwumarogie.

PRESIDENT REPORT.

Mr. Uwumarogie thanked all exco members for showing up for the meeting and wished everyone and their families a happy holiday season. The President mentioned that the focus remained primarily convention update, dues collection and BOT payment. The President enjoined all members to assist the Financial Secretary, Morrison Osifo in making the dues payment seamless and less tasking.

Mr. Uwumarogie reiterated that July 12 -14, 2024 is the Toronto Convention date. Forty (40) rooms from the Hotel and 150 people for the Saturday Dinner will be the starting off point of negotiation with the Hotel. The numbers and figures are expected to change as more members register and pay their convention fees.

The second item the President spoke about was the Scholarship program and the letter from the ICC Principal on the last page of the agenda. Mr. Uwumarogie then touched on the 80th anniversary of ICC coming up in 2024 and how the North America Chapter can assist in the process. The next issue brought up by Mr. President was appreciation of the Archbishop. The President also highlighted the vast improvement in communication due to the functioning ICCOBA website and urged all old Boys to avail themselves the use of the website.

Mr. Uwumarogie informed all exco members present that there were 4 - 5 meetings left for the year hence it was imperative all hands must be on deck to ensure the success of the 2024 Toronto convention.

CONVENTION UPDATE

Babatope Atafo gave the exco a quick overview of the activities they've been involved in. He mentioned that the process of opening a bank account was almost complete and the registration had been done. Mr. Atafo also informed the exco that his team in Canada had visited the Sheraton Hotel and described certain similarities to the Dallas Sharaton. Mr. Atafo shared some pictures from the visit to Sheraton and reiterated the point that no contract had been signed yet and that negotiations were still ongoing.

At this point, Mr. Ogulogu Obaide took over and gave insights into discussions with Sheraton. Mr. Ogulogu indicated that 40 Rooms had been initially secured and that with more old boys signing up, they expected to reach about 75 Rooms. Each room cost C\$229.

It includes singles and doubles and can accommodate four people. Any adult age 19 and over comes with an additional C\$20. Mr Ogulogu informed the exco that the hotel promised to make more than 75 Rooms available if it became necessary.

Furthermore, Mr. Ogulogu added that a Hall and meeting room for meetings had also been secured. The hall / ballroom can accommodate 300 people. The hall can be divided into 3 different parts, but the Hotel agreed to give the entire hall for one price. All events would take place in the Hall. The Friday welcome event would occur in the foyer adjacent to the Hall. Mr. Ogulogu remarked further that a Projector was also going to be present. Mr. Atafo quickly cut in to add that they were looking at streaming some of the events live on Facebook and other social media outlets.

Turning to the issue of feeding, Mr. Ogulogu intimated the exco members that a deal was struck that the hotel folks would take back to its management. A combo arrangement was discussed whereby the food would consist or our own African food and the hotel food for about 300 people on Saturday night. The hotel requested for a name of a Nigerian vendor and according to Mr. Ogulogu, Benin cafe was given. Mr. Ogulogu added that the hotel expressed concerns about food safety being an area the hotel has on its radar. Mr. Ogulogu mentioned that the basis of negotiations with the hotel hinged significantly on the combo food arrangement which the hotel agreed to. A final ratio of 60: 40 was agreed with the hotel, with the hotel supplying 60% of the meal and the Nigerian vendor supplying 40% of the meal. Mr. Ogulogu remarked further that an email would be sent by this week stating clearly what the menu would look like. The initial contract was supposed to be signed by November 30, 2023, but an extension was now in place until December 31, 2023.

After Mr. Ogulogu's report, Mr. Atafo shared pictures of the hotel with the executive team. Mr. Giwa Osagie then asked if there was another option of hotel to compare the Sheraton deal to which Mr. Atafo answered no. Mr. Giwa Osagie said his reason for asking was due to the time factor. Mr. Atafo promised to brief his team on that area of concern. Mr. Iguodala then asked if ICCOBA was paying for the hall to which Mr. Ogulogu answered yes. Mr. Iguodala then added that with catering services being provided in large part by the hotel and all rooms being booked would usually lead to the hall being given for free. Mr. Giwa Osagie requested that Mr. Uwamarogie give a guide to the Canadian team that would form the bedrock of their negotiations.

Mr. Uwumarogie alluded to the fact that both Mr. Iguodala and Giwa Osagie spoke from their deep well of expertise in hosting conventions in the past. Mr President noted the importance of the Toronto convention as being the first one that would be taking place with the new cost considerations that has been put in place. Couples would now pay \$200 as opposed to \$150 and singles would now pay \$125 as opposed to \$100. Mr. Uwumarogie expressed his belief that the 75 rooms commitment was too high a ceiling.

Mr. Atafo expressed his strong belief that between the local Canadian chapter and local BOT would be booking rooms at the hotel which he estimated would be about 10 rooms.

In his opinion, Mr Iguodala stated that we might meet the room criteria, but that cost was an overriding factor that might make some old boys look for cheaper hotels. Mr. Ogulogu promised that the room issue would be revisited once more by the local organizing committee.

Mr. Uwumarogie, in addressing the room issue, advised that we adhere to the agreed upon 40 rooms. John Owie chipped in by saying if the 40 rooms were met, then we can ask the hotel for more perks.

Mr. Giwa Osagie asked if the cost of the hotel can be given in US Dollars. Kenny felt anything over \$200 would disincentivize old boys from booking rooms. Mr. President while addressing the Saturday night dinner pruned the number of guests from 300 to 150. The President acknowledged the numbers can obviously change, but the best way to monitor this was by having old boys register early. Once our initial number was met, we can always go back to renegotiate the contract. Mr. Uwumarogie advised Mr. Atafo to call Mr. Omorodion in Dallas for some words of guidance. the President strongly felt that with all that ICCOBA was giving up to the hotel, a free hall was quite within reach.

Mr. Giwa Osagie reminded the Canadian chapter that it was time to start selling the convention and it was best to start right there in the host city of Toronto. Mr. Iguodala asked Mr. Atafo to request a link from the hotel rather than taking the added responsibility of taking pictures.

TREASURER'S REPORT.

In giving his report, Mr. Osagie Eweka said the association had a balance of \$50,573.02 in its coffers as of December 10, 2023.No expenses were incurred this period.

Both the Financial Secretary report and Publicity Officer reports weren't given due to the office holders being absent from the exco meeting.

CHAPTER PRESIDENT REPORT

MIDWEST REPORT

Mr. Dala Iguodala informed the exco team that the last meeting for the year 2023 was held the previous day and that all the old boys present had a thrill. Mr. Iguodala enjoined all members to spread out their recruiting capacity as many old boys across several states would be interested in joining forces if only, they could be identified. Mr. Iguodala mentioned the recruitment of two additional old boys, one from Kansas City and the other from Denver.

Along those lines, Mr. Giwa Osagie encouraged the Canada chapter to widen their recruitment efforts especially at this infancy stage. In response, Mr. Atafo alluded to 6 -7 new members in both Alberta and Manitoba who have already indicated interest in joining the ICCOBA fold.

Mr. Osayimwen suggested to Mr. Atafo the benefits of looking for and adding a veteran of Iccoba by the name of Anthony Eguavoen to their team. Mr. Osayimwen recounted the viability of Mr. Eguavoen in years past and thought having him onboard would be a huge plus to the Canada team. John Owie spoke of Mr. Eguavoen being his personal friend and promised to reach out to him too.

NEW ENGLAND REPORT.

Mr. Owie informed the exco that the last meeting of the New England Chapter took place in November. According to Mr. Owie, that meeting was called to finalize preparations for the December 17, Christmas party. According to Mr. Owie, this would be the first Christmas party post covid.

NEW BUSINESS

SCHOLARSHIP PROGRAM.

Mr. Uwamarogie spoke on the scholarship program. A note from the Principal of ICC was read to the Exco. The President informed the house that 5 scholarships was given out this year as opposed to 8 scholarships given out the previous year. The difference Mr. Uwumarogie noted was because of the time the funds are disbursed. The grand total for the 5 scholarships was N4, 225,000.

ICCOBA 80TH ANNIVERSARY CELEBRATION.

Mr. Uwumarogie informed the exco team that the 80th anniversary of the founding of ICC has been scheduled for November 4 -10 2024. A fund-raising dinner is planned for March 9, 2024. A plate of food cost N200,000. The President pleaded to all members to contribute generously to the fund as the target is N80 million. An old boy can have someone take their place with a N200,000 payment. Single is N200,000 and couples is N200,000 as well. Mr. Uwumarogie alluded to the challenge of calling for a general meeting to address this fund raiser issue. Presley Omoruyi in his comments said most of the activities organized by the Nigerian body of ICCOBA tended to overlap each other thus presenting some unique hurdles. Mr. Iguodala added that the Nigerian ICCOBA was usually late in inviting the North America chapter to its events, but always wanted the North America chapter to donate money.

ARCHBISHOP APPRECIATION.

Mr. Uwumarogie told the exco that the archbishop was invited to the Dallas convention to give the keynote speech and no monetary compensation was given to the archbishop. The President suggested that the sum of \$500 be sent the archbishop as a token of our appreciation for honoring our Dallas invitation. Mr. Owie suggested that \$1000 was more appropriate as a gift since the archbishop paid for his own airline ticket. Dala Iguodala chimed in by saying the archbishop was one of us and our spiritual leader hence we're not necessarily paying for his services. Mr. Iguodala suggested that \$500 was enough as a show of appreciation. A motion for \$500 to be given to the archbishop was proposed by Mr. Iguodala and seconded by Presley Omoruyi. The motion passed.

Mr. President reminded everybody to avail themselves of the website in keeping abreast of developments in the association.

MATTER ARISING

Dr. Omoruyi informed the exco of the passing of the Father of Ndidi Enewosu, an old boy of the 1982 set. Dr. Omoruyi thanked the Midwest chapter out of Chicago and the 1982 set for rallying around Mr. Ndidi.

Mr. Owie also intimated the exco of the passing of the mother of Anthony Edokpa , vice president of the New England chapter out of Boston. Mr. Owie added that necessary support was being put in place to assist Mr. Edokpa .

ADJOURNMENT

Motion for adjournment was moved by Dr. Omoruyi and seconded by Mr. Owie. The meeting was adjoined at 8:20pm CTD. The closing prayer was said by John Owie.
