My special thanks to the members of the board of trustees for their unwavering financial support of ICCOBA North America. You have truly become the foundational resource of this noble association. Thank you to all our members who dutifully paid their annual dues. The executive and I appreciate your sacrifice. We are working hard and assure you that all monies received have been and will continue to be judiciously utilized for the advancement of the association vision, mission, goals, and objectives.

Our executive team was elected in 2019. For the past three year we have worked hard to achieve our stated goals. Our focus was to improve four specific areas of our association. They are 1) Growing membership 2) Putting our finances in order and developing alternative methods of fundraising 3) Examining convention successes and failures through examining and adhering to line items reporting and 4) Revising, modifying, or amending the constitution. Let's examine current state of the association based on those four areas.

Growing membership

Thanks to our welfare officer Mr. Adam Bello-Osagie our WhatsApp platform was the first initiative implemented the first month of this executive team in August 2019. Currently, we have a total of 133 members on the platform. The consensus from executive deliberation on this matter was that it will facilitate the transition of platform members into registered and dues paying ICCOBA NA membership. We are still hoping and enthusiastic of the outcome.



Since 2019 we have increased registered membership by **8** (Umah Okpara, Philip Osehobo, Solomon Okogun, Hope Uwumarogie, Daniel Okhilua, Peter Idemudia, Ehi Arebamen and Emmanuel Akhile). We have about 37 active members that have paid their membership dues up to 2021, another 13 members paid till 2020, and about 20 members that have paid in one form or the other for a total of 69 registered members. Presently, the vice president Dr. Presley Omoruyi is working with the worldwide president and his executive team to create

worldwide data base for all iccobites around the world. So, the outlook for ICCOBA NA to increase its registered membership is very promising.

Putting our finances in order

When this executive team came into office, the association had a total account balance of \$3,636.00 as of July 31st, 2019. After several deliberations and insightful discussions on alternative funding source and methods of revenue collection, the executive team approved the creation of the board of trustee and the Zelle account. Thanks to the board of trustee and our diligent dues paying members we have raised up to \$60,000,00. We currently have a bank account statement balance of \$45,834.30 after some expenditures towards the convention and other annual reoccurring expenses. Thanks to our creative treasurer Mr. Osagie Eweka, we instituted the transaction processes in which all debits from the account must go through the vendors. Then, we encouraged all credits into the account (BOT donation and dues payments by members or other receivables go directly into the account through Zelle and direct deposit. These processes allowed for the line-item identification and analysis of bank statement credits and debits. Finally, thanks to our able financial secretary Mr. Morrison Osifo, his tenacity and cordiality in reminding members to do the needful and meet their respective obligations to the association helped in improving the association finances.

Examining Conventions successes and failures

To improve efficiency, effectiveness and responsiveness with our convention, the executive team created a budget comparison and analysis chart that dive into line-item cost and benefit from conventions since 2016. The idea is to discover areas of improvement. We needed to either reduce or increase expenditures to be more responsive to the needs of our members and guests during the convention; and more specially to look at profit and lost. The chart is in the exhibit section.

Revising, modifying, or amending the constitution

Again, after several deliberations and insightful discussions on the constitution, the executive team recommended that the constitution review committee (CRC) be activated. The committee was inaugurated on November 22, 2020. It comprised of Mr. Andrew Aideyan, Major Cletus Obahor and Barr. Ben Omorogbe. The committee started its official work on December 6, 2020. Its members selected Barr. Ben Omorogbe as their chairperson. Thanks to all three members leadership the constitution was revised and submitted to the executive team for a review. The executive reviewed and made additional recommendations which were incorporated by the CRC. The final copy was submitted to the executive. Following the approval, it was submitted to the board of trustee for review and recommendations. The final copy of the revised constitution was presented to the house during a Zoom general meeting on April 24, 2022. It was unanimously approved at that meeting. However, it was understood that true final vote of approval will be conducted during our 2022 convention in Atlanta,

Georgia. Again, thanks to the constitution review committee members for their hard work and commitment to the association.

Other Programs and Activities approved by the executive team

- 1. Scholarship programs for students in our alma mater and children of our members in the United States
- 2. Current ICC students' participation in Edo State intercollegiate soccer program

Continuation of Projects from outgoing Executive

- 1. Implementing the increase of monthly dues from \$15.00 to \$20.00
- 2. Collecting contributions to build ICCOBA House in Benin City
 - Total donations as of August 2022 is **N8,248,040.00**

Others

1. Logos (the difference between ICCOBA and ICC logos)

PREAMBLE:

We, the members of Immaculate Conception College, Old Boys Association, aware of the need for cooperation and unity among Old Boys in the USA and the rest of North America, do hereby freely associate and

agree to the following articles of our faith and purpose in this constitution which shall be supreme. Where other decisions of the Association are inconsistent with the provisions of

the Constitution, this Constitution shall prevail.

ARTICLE 1: NAME

Section 1:1 The name of the Association shall be Immaculate Conception College Old Boys Association of North America or ICCOBA -NORTH AMERICA, herein referred to as "The Association"

Section 1: 2 MISSION STATEMENT

To uphold the motto of our alma mater: (*Semper et Ubique Fidelis* – Always and Everywhere, Faithful) wherever we are, in whatever we do and in whatever position or condition we find ourselves.

Section 1: 3 VISION STATEMENT

To build, maintain and manage effectively and efficiently our alma mater, with all materials and physical endowments, representative of the quality and caliber of graduates from inception, for generations of students today and tomorrow.

Section 1: 4 CORE VALUE STATEMENTS

- (a) <u>Integrity</u> in thought, words and deeds; in service to family, alma mater, community, nation and the world; always and everywhere, be loyal, just and truthful.
- (b) <u>Cooperation</u> with one another as one family and team members, trained and groomed to be leaders with compassion, integrity, and respect for human dignity.
- (c) <u>Comportment</u> of ourselves in both private and public places, being at the best behavior and etiquette that exemplify the training of our alma mater.
- C-1: <u>Lack of Comportment</u> of ourselves in both private and public places, <u>Not</u> being of the best behavior and etiquette that exemplify the training of our alma mater at all times shall be sanctioned by an Association-approved formal suspension of the offending member for a period -up to twelve (12) months from the date of the offense.
 - C-2: <u>Membership Re-instatement</u> a member on Association-approved suspension shall be eligible for re-instatement by submitting a formal written request to the Association seeking re-instatement.
 - C-2a: the member requesting re-instatement shall render a sincere apology to the Association, in person, during the convention at which request for re-instatement is being considered.
 - C-2b: by a two-third (2/3) vote of the eligible voting members present, the Association shall indicate that it is satisfied with the apology rendered by the offending member, and shall then vote to re-instate such a member to full membership.
 - C-3: <u>Criminal Conviction</u> a member who commits a felony or who runs afoul of the laws of the land for which the member receives a criminal conviction from the justice system of the land, shall be summarily dismissed from membership of the Association without any possibility for re-instatement.

- (d) <u>Orderliness</u> in thought, words and deeds, nurturing orderliness in place of disorderliness, remembering always that the ethical standards of I.C.C. abhor disorderliness.
- (e) <u>Brightness</u> in spirit, mind and body, in erudition and performance of duty; and continually demonstrating bright and sterling content of character.
- (f) <u>Accomplishment</u> of God's Master Plan for each and everyone, of self-set goals and objectives, come what may.

ARTICLE 2: AIMS

Section 2:1

The Aims of the Association shall be to:

- (a) Foster goodwill among all ICC Old Boys with a view to establishing cooperation and unity based on mutual respect, understanding, and love of the Alma Mater.
- (b) Concern itself with the welfare and uplifting of the Alma Mater.
- (c) Ensure that members live with a high standard of morality and integrity
- (d) Organize social/educational activities annually on a date to be fixed at a general meeting of the Association.
- (e) Take part in productive activities that will enhance the welfare of community.

ARTICLE 3: ADDRESS; FISCAL YEAR AND NON-PROFIT STATUS Section 3: 1

The address of the Association shall be care of the Secretary General.

- 3.2 The fiscal year of the Association shall commence on July 1 and end on June 30 of each year.
- 3.3 The Association shall maintain a not-for-profit status and, at all times, observe all necessary or required requirements to maintain such status.

ARTICLE 4: ANNUAL CONVENTION AND GENERAL MEETINGS Section 4: 1

The Association shall hold an Annual Convention during the (i) second week of July or (ii) on a date that is close in proximity as may be determined in advance by the Executive Officers. When the Annual Convention is held pursuant to (ii) above, a notice of not less than 90 days shall be given to the general membership. A meeting of all members (Convention Meeting) shall be convened during the course of the convention.

Section 4.2

In addition to the Convention Meeting described in Section 4.1, the Association shall hold not less than two General Meetings during the fiscal year; the first General Meeting shall be held in the third week of October and second General Meeting shall be held in the third week of April.

Section 4.3

The Convention Meeting and the General Meetings may be in-person or may be held virtually by or through telephonic or other electronic means.

Section 4.4 MEETING PROCEDURES

- (a) Quorum for a General Meeting shall be formed by one third (1/3) of active members, or where not less than 25 (Twenty-Five) active members of the Association are present.
- (b) Prayers shall be said before and after meetings by any member called upon by the presiding officer.
- (c) Minutes of the previous meeting shall be read and adopted at the beginning of every General Meeting. The presiding officer and Secretary General shall append their signatures to minutes so adopted.
- (d) Decisions at meetings shall be by consensus or put to a vote.
 - (i) Each member shall be entitled to one vote.
 - (ii) Voting shall be by a show of hands or by balloting.
- (e) Any ordinary motion put to the vote at a General Meeting shall be carried by a simple majority of the members present at the meeting. In the case of a tie, the presiding officer of the meeting shall be entitled to a second or tie breaking vote.
- (f) The official language of the Association shall be English.
- (g) A member may address the general membership after he has been recognized by the presiding officer.
- (h) A member who's been recognized by the presiding officer to address the general membership shall not be interrupted.

ARTICLE 5: MEMBERSHIP AND MEMBERSHIP DUES

Section 5: 1 Qualification: Membership shall be open to any person:

who (i) completed not less than two academic years, or (ii) obtained the West African School Certificate or Higher School Certificate at Immaculate Conception College or any of its predecessor or successor schools that were physically located on the campus of Immaculate Conception College in Benin City. (Predecessor and Successor schools include, but may not be limited to, Kelly College and Bishop Kelly College.)

Section 5:2 DEFINITIONS: An active member is one who:

- (a) Attends at least one general membership meeting of the Association during a fiscal year.
- (b) Meets all financial and other obligations to the Association.
- (c) Is not under suspension by the Association.

Section 5:3 ADMISSION:

Membership shall commence upon an approved membership application and payment of any required dues or fees.

Section 5.4 Dues

- (a) Each new member shall pay an application registration fee of \$ 50.00 (Fifty USD) at the time such membership application is submitted.
- (b) Each member shall pay annual dues of \$240 (Two Hundred and Forty USD) which may be paid in lumpsum or in monthly or quarterly installments.
- (c) A person shall not be considered a member until the registration fee and membership dues are paid in full.

ARTICLE 6: FINANCE

Section 6:1

- (a) Any non-emergency expenditure exceeding \$1000.00 (Five Hundred USD) to be incurred on behalf of the Association must be discussed and approved by the general membership before money for such expenditure is disbursed.
- (b) The Account of the Association shall be audited by an Ad-Hoc Committee appointed by the Executive Committee at least once during the fiscal year.

ARTICLE 7: BANKERS

Section 7:1

All monies belonging to the Association shall be paid into an approved Bank Account by the Treasurer. Authorized signatories to the Bank Account shall be the President, the Vice President, the Treasurer and the Secretary General.

Section 7:2

All withdrawals shall be signed by any two or more of the following authorized signatories: President, Vice President, Treasurer and Secretary General.

The Treasurer shall pay into the Association's Bank Account, all monies accruing the Association within 3 business days of receipt of such monies.

ARTICLE 8: OFFICERS OF THE ASSOCIATION

Section 8:1 The EXECUTIVE COMMITTEE

The Officers of the Association, which shall constitute the Executive Committee, shall be:

- (a) President
- (b) Vice President
- (c) Secretary General
- (d) Assistant Secretary General
- (e) Treasurer
- (f) Financial Secretary
- (g) Director of Social/Publicity

Section 8:2 TENURE OF OFFICE

- (i) The tenure of office of an Officer shall be 24 (Twenty-Four) calendar months, commencing on the date of election at a July Annual Convention and ending -at the second Annual Convention following the time of their initial election.
- (b) If a "vote of no confidence" is passed on the Executive Committee, a Care-taker Committee of five members shall be established by the General Membership, with a two-third majority vote of those present at the meeting where such action is taken, to conduct the affairs of the Association until the next General Meeting when new elections shall be held.
- (c) No member shall hold the same office for more than two consecutive terms. In the event of a vacancy in any office, a bye election shall be held to fill the vacancy.

Section 8: 3 ELIGIBILITY FOR ELECTION AND VOTING

Only an active member is eligible to vote, nominate or be nominated to contest for any elective office. A person who is not an active member may not hold any office.

ARTICLE 9: DUTIES OF OFFICERS

Section 9:1 THE PRESIDENT

- (a) The President shall: preside over all meetings.
- (b) Have the power to refer special matters affecting the Association to an Ad-Hoc Committee.

- (c) Have a casting/deciding vote on any issue in the event of a tie vote at a general membership meeting.
- (d) Have authorization as a signatory for any withdrawal from the bank account of the Association.
- (e) Have authorization to spend no more than \$500.00 (Five Hundred USD) for such emergency that may arise in conjunction with the Secretary General.
- (f) Have the power to call an emergency meeting when necessary.
- (g) Provide the state of the Association at the annual General Meeting.

Section 9:2 THE VICE PRESIDENT

- a) The Vice President shall perform the duties of the President in the absence of the President.
- b) Shall perform other duties assigned by the President or the general membership.
- (c) Shall have authorization as one of the signatories for any withdrawal from the bank account on of the Association.

Section 9:3 THE SECRETARY GENERAL

- (a) The Secretary-General shall be responsible for the running of the Association's Secretariat.
- (b) Shall maintain custody of all properties of the Association.
- (c) Shall keep the books and records of the Association, including all the minutes of the General Meetings.
- (d) Shall make copies of minutes of General Meetings available to members in a timely manner.
- (e) Shall solicit input from members for meeting agendas and disseminate agendas prior to meetings.
- (f) Shall have authorization as one of the signatories for any withdrawal from the bank account on of the Association.
- (f) Shall provide an annual report at the convention.
- (g) Shall maintain an attendance register of every General Meeting.
- (h) Shall preside over general membership or other properly convened meetings of the Association in the absence of the President and Vice President.

Section 9:4 THE ASSISTANT SECRETARY GENERAL

(a) The Assistant Secretary General shall assist the Secretary General in his duties and perform such duties in the temporary absence of the Secretary General.

- (b) Shall take attendance at General Meetings.
- (c) Shall perform any other duties as may be assigned by the Secretary General or the President.

Section 9:5 THE TREASURER

- a. The Treasurer shall keep all records of revenues and expenditures.
- b. Shall pay all monies of the Association to the bank not later than 3 (three) business days after the receipt of the monies and forward a copy of the payment teller to the Secretary General and the President within a week of such lodgment.
- (c) Shall render semi-annual statements of the Association's account(s).
- (d) Shall have authorization as one of the signatories for any withdrawal from the bank account on behalf of the Association.
- (e) Shall preside over general membership or other properly convened meetings of the Association in the absence of the President, Vice President and Secretary General.

Section 9:6 THE FINANCIAL SECRETARY

- (a) The Financial Secretary shall receive all monies on behalf of the Association.
- (b) Shall hand over all such monies within 24 (Twenty-Four) hours of collection to the Treasurer and obtain a receipt for such monies.
- (c) Shall pay all monies collected to the bank within three business days during the absence of the Treasurer. Evidence of such payment shall be forwarded to the Secretary General and the President within 7 (seven) days.
- (d) Shall maintain a list of active members and financial records of the Association.
- (e) Shall send reminders of outstanding monthly dues to members quarterly and semi-annually.
- (f) Shall give a financial report at each meeting.
- (g) Shall provide a year-end financial report at the annual convention.
- (h) Ensure that the Association's tax filings or other mandated filings, documents or submissions are filed with or submitted to the Internal Revenue Service and/or other appropriate tax or regulatory agencies.

Section 9:7 DIRECTOR OF SOCIALS / PUBLICITY

- (a) The Director of Socials / Publicity shall issue all official statements on behalf of the Association, as directed by the Executive and/or the General House.
- (b) Shall be responsible for giving publicity to the activities of the Association.

- (c) Shall coordinate all social activities of the Association.
- (d) Shall update or coordinate with a web master to update the Association's Website.

Section 9:9 THE EXECUTIVE COMMITTEE

- (a) The Executive Committee shall have responsibility for the day-to-day business of the Association and make decisions that are in the best interest of the Association.
- (b) Any decision by the Executive Committee or any Officer that could impact the legal standing or welfare of the Association, or that binds, or has the potential or possibility to bind, the Association shall be brought before the General Membership for discussion and/or approval.

ARTICLE 10: POWERS OF-MEMBERS

Section 10:1 Supreme Authority of the Association

- (a) The supreme authority of the Association shall be vested in the General Membership
- (b) The General Membership shall have over-riding powers over -any decision of the Executive Committee or other Committees and sub-committees by a simple majority vote of those present at the meeting where such action is taken, provided that proper notice has been given to all active members.
- (c) The General Membership shall have power to send representatives to appropriate individuals and organizations with a view to promoting the objectives of the Associations.
- (d) The General Membership shall appoint a member of the Executive Committee or any member of the Association to preside over a General Meeting in the absence of the President, Vice President, the Secretary General and the Treasurer.

ARTICLE 11: BOARD OF TRUSTEES

1. <u>COMPOSITION</u>

The Board of Trustee (BOT) shall consist of not more than -20 individuals (each a "Trustee," collectively, "Trustees")) who may be members or supporters (non-members) of the Association. The Executive Committee shall recommend each prospective Trustee for acceptance by the General Membership by a simple majority vote at a properly convened meeting. A person recommended to be a Trustee shall have impeachable character and reputation and be committed to the ideals of the Association.

2. TERM

The term of a Trustee shall be three (3) years, subject to reappointment for a maximum of one additional three-year term upon the recommendation of the Executive Committee and approval by the General Membership at a properly convened general membership meeting. No person may serve more than a total of six consecutive years as a Trustee. A vacancy on the BOT may be filled as provided in Section 1 of this Article 11.

3. ROLE

The BOT shall serve in an advisory role to the Executive Committee and the Association. Be committed to providing financial support for the Association; Shall meet as often as may be necessary but not less than two times during a fiscal year; and make recommendations to the Executive Committee for the advancement of the Association. The BOT shall arbitrate with finality any issues or disputes that the Executive Committee is unable to resolve.

ARTICLE 12: AMENDMENT

Section 13:1 Notice of Amendment

This Constitution shall be subject to a general review as and when necessary. Notice of an Amendment to this Constitution, or any part hereof, shall be given to all active members by or through proper medium that ensures delivery. Any amendment to the Constitution shall be approved by at least two-thirds (2/3) majority of the members present at a properly convened general meeting. Any amendment that is adopted without proper notice to all active members shall be null and void.


