President's Report

The president Mr. Sunday Uwumarogie welcomed everyone to the first ICCOBA North American Convention since 2019 in the aftermath of the Covid 19 pandemic. He thanked God almighty for sparing our lives through the difficult period of the crisis. He called on members to observe a one-minute silence in remembrance of our brothers, colleagues and family members who passed away in the last three years. May God almighty grant their souls eternal rest, Amen.

Gentlemen distinguished guests, it is with great delight that I welcome you to the 5th ICCOBA national convention holding in Atlanta, Georgia. He paid tribute to members of his executive team: Dr. Presley Omoruyi (vice president), Mr.Kenny Giwa-Osagie(Secretary General), Mr. Morrison Osifo(Financial Secretary), Mr. Osagie Eweka(Treasurer), Mr.Adam Belo-Osagie(Welfare Secretary), and Mr. Fidel Casto-Cole(Social Secretary) for their dedication, and steadfastness in piloting the association through one of its most difficult times in recent memories. He thanked Mr. Fidel Castol-Cole and Mr. Osasuyi Idubor, co-chairs of the local organizing committee for the excellent work of putting the convention together.

To the members of the Board of Trustees (BOT), the president Mr. Uwumarogie was equally gracious to them for their unwavering support of ICCOBA North America. You have become the backbone and foundational resource of this

association. He assured them that their contributions as well as other funds realized by the association will be judiciously utilized for the advancement of the association's mission, vision and objectives. He thanked them for what they have done to move our association forward. The following members were recognized for being the first batch of the board of trustee members.

This executive was elected to office in 2019, and at its inception our focus was to improve on four specific areas of our association.

- a. Growing our membership
- b. Developing alternative method of fundraising
- c. Examine convention successes, failures and adhering to line-item reporting.
- d. Modifying and amending our constitution.

Thanks to Mr. Adam Belo-Osagie, the creation of the WhatsApp platform in 2019 was our first initiative to address the issue of growing membership. We currently have about 133 members on the platform. Our hope was that creating this platform will facilitate the transition of participants on the platform to active dues paying members; unfortunately, the gain in dues paying members has not matched the enthusiasm generated with the creation of the platform. Thus far, we have about

eight members from the group who have transitioned to being active paying members of the association. The new members were recognized.

The president called on those present at this general meeting to make a commitment to bring one more old boy to the convention next year. Our goal he stated is to make all 133 members on the WhatsApp platform active dues paying members. Dr. Presley Omoruyi, the current vice president, is working with the Worldwide President to create a database of all ICCOBITES around the world. The outlook for ICCOBA North America to increase its membership is promising.

With regards to our finances, when this executive took office in 2019, the balance in the association's account was \$3,636.00(Three thousand, six hundred and thirty-six dollars only). Through insightful deliberation and brainstorming, this executive came up with an innovative idea on how to improve our finances. The creation of the Board of Trustees and use of the zelle method of transaction has been a game changer for the association. With the cooperation of the BOT members, the association has been able to generate upward of \$60,000. As at last Friday the balance in the association's account was \$45,834.30.

In the course of holding this convention, various charges have been going in and out of the account, thanks to Mr. Osagie Eweka our treasurer for his diligent work in that office. Moving forward all debits from the account must go through a vendor providing service to the association. All deposits into the account are through zelle. This process has made line-item identification of transactions easy to track. I must not fail to acknowledge the tireless work of the financial secretary Mr. Morrison Osifo for his unrelenting effort at reminding members to pay up their dues and other obligations to the association. Our finance department has been an integral part of this success.

On improving our conventions, this executive created a budget analysis comparison chart. Our goal was to discover areas of improvement that are responsive to our needs, most especially in the areas of expenditure. In doing so we are able to anticipate what our expenses will be by looking at these charts and making comparisons between each of our previous conventions. We can anticipate what our cost will be, what our revenue will be and then make necessary adjustments in our budget to avoid the culture of losses which has plagued this association moment after its national conventions.

Revising and modifying the constitution

As was mentioned earlier, revising our constitution was another task embarked upon by this executive. After several meetings and deliberation, the executive team recommended the activation of the constitution review committee. This committee was inaugurated on Nov, 22 2020. It consisted of Mr. Andrew Aideyan, Barrister Ben Omorogbe and Major Cletus Obahor(rtd). Thanks to the tireless effort of

these gentlemen, the constitution was revised, and their work was submitted to the national executive team for review. Following the review by the executive, recommendations were made and resubmitted back to the committee. The revised constitution has been approved by the executive team and the board of trustees. The full house approval will be conducted at this national convention holding in Atlanta.

Other programs approved by the executive team are.

- A. Scholarship program for current students of ICC, and children of old boys in North America
- B. Participation of current students in the Edo state inter collegiate soccer program. This motion for students of ICC Benin City to participate in this program was moved by Mr. Tony Woghiren and seconded by Dr. Emma Osagiede. The vote was unanimous.
- C. Implementation of the new membership dues.
- D. The collection of funds to complete the ICCOBA House. So far, a total of N8, 248,000.40 has been disbursed by the association.
- E. Use of ICCOBA logo

Finally, the president thanked everyone for their attendance at this convention. Please donate generously to support the scholarship program. Let us continue to be good role models and advocate for leadership that believe in education. Once again, he thanked Mr. Fidel Castro-Cole and Mr. Osasuyi Idubor for their hospitality.

Treasurer's Report

Mr. Osagie Eweka presented his report. According to him as of August 9th, 2022, the balance in the association's account was \$45,834.37(Forty-five thousand, eight hundred and thirty-four dollars, thirty-seven cents). An updated account will be presented later as there were ongoing expenditures at this convention that have not been documented. A comprehensive report will be presented after the convention, he stated.

Financial Secretary's Report

The financial secretary Mr. Morrison Osifo delivered a short address to the house. He craved the indulgence of members to delay presenting his report at a later time. A lot is going on at this time of the convention and as a result a more comprehensive report will be presented later. He thanked the BOT for doing right

by the association and putting us on good financial standing. He expressed appreciation for their generous donation.

Local Chapter Report

Chicago

Mr. Dala Iguodala, the president of the Chicago local chapter gave a short address. Currently, the Chicago Midwest Chapter has roughly about 25 members. To further strengthen the local chapter and the national body, we have reached out to neighboring states with no active viable chapters to join the Midwest chapter. As we speak, we have active members from three neighboring states of Michigan, Minnesota and Indiana. 13 of our active members are attending this convention from the Midwest Chapter. He called on other chapters to emulate Chicago's initiative to adopt members with no active chapters.

New York/New Jersey

Mr. Frank Ogbahon was unavoidably absent at this convention, the president called on Engineer Andrew Aideyan to give a brief summary on the N.York/N.Jersey chapter. According to Engineer Aideyan, Mr. Ogbahon just prior to the pandemic had informed the members in the Tri state region that he was retiring and would be spending most of his time living in Nigeria and the United States. He was thinking of handing over the leadership of the chapter to a new president when the pandemic hit. Unfortunately, he stated there has not been any meeting following the pandemic for this transition to a new leadership to guide the chapter. Members reach out individually on a regular basis as a family not under the umbrella of ICCOBA.

Now that things are gradually picking up, we hope to schedule a meeting such that the mantle of leadership can be transferred to a new president. We will reach out to him after this convention so that the baton can be passed to a new president. Mr. Tony Woghiren, a member from the Tri State region assured the general assembly that members from the New York/New Jersey axis will continue to meet their financial obligation to the association. Dr. Presley Omoruyi contributing to the discussion advised that the new president be a person with a passion for the work of the association. You must get your choice of a leader right, he submitted.

California

Engineer Chris Igbinedion gave a brief report on the West coast. According to him, California has no active viable chapter. A few years ago, a few individuals came together to facilitate hosting of the convention. We are still hoping to grow. We have no meetings and individual old boys remit their dues to the national body he stated.

Boston

Mr. John Owie's report was presented by Mr. Ise Osayiwen, the secretary of the Boston chapter, according to him the chapter's activities were dealt a blow by Covid 19. Prior to the pandemic meetings were held consistently as of now there are 10 active members. We are trying to revitalize our association. Our first meeting was held a month and a half ago, and it was well attended. The trajectory for our chapter looks good, we are hoping to expand our membership base, he stated. At this convention we have four to five members in attendance. He commended Mr. John Owie for his visionary and exemplary leadership.

Kansas City

Mr. Nicholas Ogbevoen presented the report of the chapter on behalf of the president Mr. John Ehiwe. According to him, the founding member of the chapter in Kansas Major Cletus Obahor(rtd) has relocated to Dallas, Texas. No formal meetings have been held in the past three years. Mr Ehiwe and I spoke recently and are seriously considering the way forward for the chapter. In light of this situation a decision will be made soon as to whether to become affiliated to the national body directly. In light of this discussion Dr. Presley Omoruyi suggested the regionalization of the association as a way forward for future consideration.

Dallas

Engineer Augustin Ekupe responded on behalf of the Dallas chapter. Just like previous speakers, covid has been devastating, but also most of our previous members have relocated. Mr. Morrison and I have spoken on how we can revitalize the Dallas chapter. We are working on it. He promised the house.

Canada

In recognition of the Canadian chapter, the president called on Chief Inneh to provide some updates on the chapter. Chief Inneh thanked the president for the recognition in spite of the fact that the chapter has not been active. He promised to use this convention to rally other ICCOBITES in Canada into a formidable chapter. Please send me the names of any ICC old boy in Canada that you know. I will do my best to ensure that Canada is ready, and maybe host the next convention after the 2023 convention in Dallas. Dr. Emmanuel Osagiede thanked Chief Inneh for taking on the responsibility of mobilizing the Canadian axis. You have a central role to play in ensuring that the Canadian chapter becomes a viable chapter in North America.

Old unfinished business

The president thanked all the leaders of the various chapters who spoke on behalf of the chapters. Let us do all we can to rise again and get these chapters running. He also used the opportunity to recognize some delegates from Maryland.

The motion to adopt the revised constitution was moved by Dr. Austin Agho and seconded by Dr. Osaretin Oronsaye. By a unanimous vote the revised constitution was adopted.

The scholarship program generated a number of debates around the amount earmarked, and the modalities for its implementation. Some members expressed concerns about sustaining the amount of \$5,000.00 yearly for the program. Some members wanted the beneficiaries to be the current students of ICC in Benin city alone. Others muted the idea of investing the amount in an endowment or foundation. This discussion went back and forth for a while. At the end the amount of \$5,000.00 was agreed upon as the funds for the scholarship program. Mr. Lionel Osaghae proposed a motion to set aside the sum of \$5,000.00 yearly for the scholarship program; his motion was supported by Dr. Emmanuel Osagiede.

On modalities for implementing the program, the house directed the executive team to look further and come with their recommendation at the next general meeting.

The role and responsibilities of the board of trustees was spelt out at this meeting by the president. The funds donated by our BOT become the backbone of all our conventions. Once you have completed a term of three years, a BOT member can choose to continue a second term or choose to withdraw. He read out the names of those members who were withdrawing their membership at this convention and solicited for new membership. Chief Chris Inneh and Dr. Philip Osehobo were announced as the new members of the BOT.

Host for 2024 and future conventions.

The choice of the next host of the convention was tabled at the convention. The Chicago president declined the offer to host the 2024 national convention. while thanking the association for the offer, he laid out reasons for declining at this time. Mr. Morrison Osifo, having heard Chicago decline the offer to host the 2024 national convention, expressed the interest of the Dallas chapter. It's been a while since Dallas hosted the convention, and having discussed with my senior Engineer Augustine Ekukpe, we will be honored to host the 2024 convention in Dallas he stated. His offer for the Dallas chapter to host the 2024 national convention was gladly accepted by the house. Discussions about the future host of the national conventions continued with no definite resolution at this time.

Current Affairs, Joys and Concerns.

1. Mr. Emmanuel Woghiren, a member of the 1962 set who was present at this convention addressed the house. He thanked the North American chapter for not forgetting the alma-mater in Benin. I am highly impressed by the fact that this association has continued to hold its meeting despite all of the difficulties these past few years. He thanked the leadership of the association for the support of the ICCOBA House in Benin. We shall be looking up to you in Benin as we begin the second phase of the project he stated.
2. Dr. Presley Omoruyi the vice president of the association called the attention of the house to the loss of Dr. Osazee Oseki. He also brought focus to the plight of Mr. Olalekan Oguntoyinbo and Mr. Festus Obanor both of whom have been dealing with one health issue or the other. He appealed to current members to support these founding members of the association with a benevolent offering, as we pray for their recovery. A total of \$1,390.00 was realized for these members during the meeting session.
3. Mr. Festus Obanor expressed appreciation to the members of the 1976 set for their immense support. He thanked the association as a whole for coming to his aide.
4. Mr. Dala Iguodala expressed his thanks and appreciation to the Chicago chapter for their support as well.
5. Mr. Osbert Evbuomwan thanked the president Mr. Sunday Uwumarogie for his leadership. Your initiative of creating the Board of Trustees is something I intend to share with the Benin branch. so do not be surprised when you hear about it during your visit to the Benin branch, he told Mr. Uwumarogie

Adjournment

The motion to adjourn the meeting was moved by Engineer Mathew Odigie and seconded by Dr. Emmanuel Osagiede. The closing prayer was offered by Mr. Emmanuel Woghiren

President Report

On behalf of the executive team, I welcome everyone to the 2023 ICCOBA NA Convention.

My thanks to the local organizing committee chairman Dr. Garvey Ehigie Omorodion and the honorable committee members for exceptional work in making sure that our delegates, and guests will have rewarding and delightful experiences in the “BIG D” (Dallas). Thanks for your determination to make this weekend memorable.

The current executive team has been in office since 2019. Their term has come to an end after four years of exceptional service to our association. As the president, I am humbly proud of the extraordinary achievements of this team. I thank every member for the passion they brought in service for our association. They are men of impetuosity in their love for the association. It is their individual purposefulness and avidness in carrying out the responsibilities of their respective offices that have led to the tremendous growth this association has experienced in the past four years. Thank you, my fellow executive team members, for your commitment and dedication to the association. Your passion and purposefulness were instrumental in moving this association to its current level of productiveness.

My special thanks to the members of the board of trustees for their unwavering financial support of ICCOBA North America. You are the foundational resource of this honorable association. We have three new board of trustees, they Dr. Peter Uyi Arasomwan, Dr. Stanley Usen and Chief Chris Omoregie Inneh. We thank you for your willingness to serve as trustees. Thank you to all our members who devotedly paid their annual dues. The executive and I appreciate your sacrifice.

This executive team was elected in 2019. For the past four year we have worked hard to achieve our stated goals: 1) Growing membership 2) Putting our finances in order and developing alternative methods of fundraising 3) Examining convention successes and failures through examining and adhering to line items reporting and 4) Revising, modifying, or amending the constitution.

Growing membership

Currently, we have a total of **146** members on the platform, an increase of 13 members since August 15, 2022. We have increased registered membership from **8** last year by 6 to 14 this year.

Putting our finances in order

Our revenue collection method and payment of contractors are through the Zelle account. Thanks to the board of trustee and our diligent dues paying members and convention donors, we have raised over **\$74,000,00**. On August 15, 2023, during last year's convention our bank account statement balance was **\$45,834.30**. The end of the year financial report, after the convention financial report was completed on August 30, 2023, shows **ending account balance of \$51, 320.59**. Today, we are reporting account balance of **\$60,228.21**. The treasurer and the financial secretary will provide detail analysis on their extraordinary work in putting our finances in order. Again! Thanks to our creative treasurer Mr. Osagie Eweka, all credits are through zelle, and all debits are mostly through debit or credit cards These processes allowed for the line-item identification and analysis of bank statement credits and debits without going through reimbursement of third parties. Finally, thanks to our able financial secretary Mr. Morrison Osifo, his tenacity and cordiality in reminding members to do the needful and meet their respective obligations to the association helped in improving the association finances.

Examining Conventions successes and failures

We have developed convention comparison framework that allows us to dive into line-item cost and benefit analysis of each convention since 2016. We know the areas of improvement. We needed to reduce expenses and increase revenue related to the convention. The location of our convention is a main factor that increases our cost because of the cost of the meals and drinks. We should agree to increase the registration fees to at least cover the cost of meal. We should encourage other means of increasing revenue that include but not limited to buying advertisement page on the brochure. But all things are possible if we increase members attendance at the convention.

Revising, modifying, or amending the constitution

Again, thanks to the CRC (Constitution Review Committee) members, Mr. Andrew Aideyan, Major Cletus Obahor and Barr. Ben Omorogbe, the constitution was amended and then approved on August 13, 2022, at the last convention in Atlanta, Georgia. It was unanimously approved.

Other Programs and Activities approved by the general members under this executive team.

1. Annual Scholarship funds of \$5,000.00 current students in our alma mater
2. Collecting contributions to build ICCOBA House in Benin City
- Total donations in the amount of **N8,248,040.00**
3. Changing the logo to ICCOBA logo instead of using ICC logo.
4. Implementing the increase of monthly dues from \$15.00 to \$20.00
